**FOURTH IDENTIFICATION OF ADDITIONAL PARTIES (IAP)
(LA PLATA RIVER SECTION)**

Pursuant to Section 1(B) of the Scheduling Order Governing Adjudication of Irrigation Water Rights in the La Plata Section ("Scheduling Order"), the State hereby files this Fourth Identification of Additional Parties ("IAP"), which joins as parties additional Known Claimants of irrigation water rights (listed on Exhibit A). Exhibit A also includes at least one address for each party.

Pursuant to Section I(B) of the Scheduling Order, **all persons and entities listed on Exhibit A are hereby joined as parties to the San Juan River Basin Adjudication.** This Fourth IAP does not affect the status of previously joined parties.

Exhibit A sets forth, to the best of the State's current knowledge, all additional claimants and other persons who should be parties to the adjudication of water rights in the La Plata River Section. However, this list of parties will change over time, as follows:


A. Joinder of Additional Claimants: Any person who is not listed on Exhibit A, but who claims water rights in the La Plata Section should file a Notice of Claim pursuant to Sections IV and VII (C) of the Scheduling Order. Also, pursuant to Section I (B) the State will file additional IAPs if it discovers additional claimants of water rights in the La Plata River Section.

B. Other Corrections: Any party may file a motion to correct an error in their name or address. Also, pursuant to Section II (C) of the Scheduling Order, parties are responsible for notifying the Court and the State of any changes in address or ownership of water rights.

Pursuant to Section I (B) of the Scheduling Order, no further order of the Court is required to join the parties listed on Exhibit A. The filing of this IAP joins them automatically.

WHEREFORE, pursuant to Section I(B) of the Scheduling Order, the persons and entities listed on Exhibit A are hereby made parties to the San Juan River Basin Adjudication.
