The San Juan Water Commission ("SJWC") and the State of New Mexico ("State"), by and through undersigned counsel, hereby give notice that on February 6, 2013, they entered into a settlement agreement ("SJWC-State Agreement") that, when satisfied, will dispose of SJWC's Objections filed in this proceeding, in particular its Objections associated with water for OSE Application No. 4818. While the terms of the SJWC-State Agreement are being implemented, SJWC is suspending its Objections and participation in opposition to the Navajo Nation Water

Rights Settlement and Proposed Decrees in the Navajo *inter se* proceeding. SJWC has reserved the right to reassert its Objections if certain terms of the SJWC-State Agreement are not satisfied in a timely manner. Once the SJWC-State Agreement is fully implemented, SJWC will withdraw its Objections filed in the Navajo Nation *inter se* proceeding.




