
The La Plata Valley Acequia Association ("LPAA") and the State of New Mexico ("State"), by and through undersigned counsel, hereby give notice that on February 6, 2013, the State and the La Plata Conservancy District entered into a settlement agreement ("LPCD-State Agreement"), concurred in by LPAA, that, when satisfied, will dispose of LPAA's objections filed in this proceeding. While the terms of the LPCD-State Agreement are being implemented LPAA is suspending its active participation in opposition to the Navajo Nation Water Rights

Settlement and Proposed Decrees in the Navajo *inter se* proceeding. LPAA may monitor and attend various proceedings. LPAA has reserved the right to resume participation and to assert its Objections if certain terms of the LPCD-State Agreement are not satisfied in a timely manner. Once the LPCD-State Agreement is fully implemented, LPAA will withdraw its Objections filed in the Navajo Nation *inter se* proceeding.


