At the recent status conference the Court asked the United States to identify any remaining federal claims in the La Plata River section of this adjudication.

The United States filed claims on behalf of the Bureau of Land Management in 2008. Those claims were the subject of Consent Orders issued in 2010. The United States has no further claims on behalf of its proprietary agencies in the La Plata section of this adjudication.


The federal claims filed by the United States in the La Plata River section addressed only the claims for the federal proprietary agencies and did not include federal Indian water rights claims by the United States or the Ute Mountain Ute Tribe. The federal Indian water rights

claims filed by the United States on behalf of the Ute Mountain Ute Tribe and the federal Indian water rights claims filed by the Ute Mountain Ute Tribe are being addressed in a separate sub-proceeding. In that separate sub-proceeding, the Ute Mountain Ute Tribe has asserted claims to the waters of the San Juan River Basin generally, and those claims could include claims to waters of the La Plata River.


