The Navajo Nation files this *Notice of Errata* with respect to the *Navajo Nation's Response to Request for Voluntary Recusal*, Feb. 4, 2019 ("Response").

At three places the Response references the transcript of the deposition of Paul Biderman, attached as Exhibit 15 to the *Request for Voluntary Recusal; or in the Alternative, Motion for Disqualification for Cause; and Motion for Revision of Orders under Rule 1-054(B)*, Jan. 23, 2019. Each of the three references mistakenly cites the deposition as "Exhibit 18, Hearing Transcript." The correct citations are as follows:
