**PLAINTIFF STATE OF NEW MEXICO'S EX PARTE MOTION  
FOR SERVICE OF PROCESS BY PUBLICATION**

COMES NOW the Plaintiff, State of New Mexico *ex rel.* Office of the State Engineer ("State"), pursuant to Section I (C) of the Scheduling Order Governing Adjudication of Irrigation Water Rights in the La Plata River Section ("Scheduling Order") and Rule 1-004(K) NMRA (2005), and moves for an order of the Court authorizing service of process by publication on the known water right claimants upon whom the State has been unable to personally serve process by mail in the manner approved by the Court. See also NMSA 1978, §72-4-17 (1965).

The State, pursuant to the requirements of Rule 1- 004 (K) and in accordance with Form 4-209, NMRA, states that after diligent inquiry and search efforts the State has been unable to serve process personally on the defendants whose names, addresses, subfile numbers and case numbers are listed as Exhibit "A" attached to this motion.

The following diligent efforts were made to locate and serve said claimants personally by mail and with a summons and complaint in the manner approved by the Court:

- [X] service at the claimant's last known residential address as indicated by current records maintained by San Juan County Assessor office;
- [X] service at the address listed in the online telephone directory listing;
- [X] a search of the real estate records of the San Juan County Assessor office;
- [X] a search of the records of the Office of the State Engineer including the WATERS database;
- [X] a search using the following internet search engines: yellowpages.com, whitepages.com and google.com. The State also attempted to contact individuals for whom a phone number could be found.

In support of this motion the State would furthermore aver:

1. The State has attempted service by Certified Mail Restricted Delivery, under the procedures designated by the Scheduling Order, on the water right claimants identified in Exhibit "A."
2. The State has exercised reasonable diligence in attempting to obtain current addresses for the known claimants identified in Exhibit "A," but the whereabouts of those claimants cannot be discovered after due inquiry and search has been made.
3. The State has not been able to personally serve process on the claimants identified in Exhibit "A" by Certified Mail Restricted Delivery under the procedures approved by the Court. In this situation, the Court's Scheduling Order, the Rules

of Civil Procedure, and the statutes governing the adjudication of stream system water rights specifically authorize the service of process by publication. *See e.g.*, Scheduling Order Section I (C), NMSA 1978, §72-4-17 and Rule 1-004(K) NMRA (2005).

4. The State therefore should be authorized to serve process on all of the unlocated claimants described herein by publication, and the Clerk of the Court should be directed to issue the NOTICE OF PENDENCY OF WATER RIGHTS ADJUDICATION TO IDENTIFIED CLAIMANTS NOT PERSONALLY SERVED BY MAIL (the "Notice") attached hereto as Exhibit "B."
5. Because the State has not been able to locate the claimants identified in Exhibit "A," the State could not seek their concurrence in this motion, and this motion is presented to the Court *ex parte*. In addition, since this motion concerns matters relating to subfile proceedings that involve only the State and individual water right claimants, the State has not served this motion on other parties to this adjudication.

For the forgoing reasons, the State moves for an order of the Court:

1. directing the Clerk of the Court to issue the above-referenced Notice to unserved known claimants;
2. authorizing the State to accomplish service of process on the unserved claimants by publishing the Notice in a newspaper of general circulation in San Juan County for three consecutive weeks; and

- 3. directing the State to file proof of such publication with the Court. A proposed Order granting this motion is submitted herewith, along with the Notice to be published.

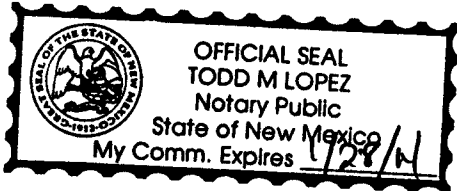

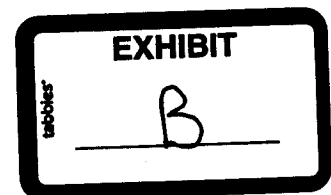

You are hereby notified that the State of New Mexico ("State") has filed a water rights adjudication lawsuit in the Eleventh Judicial District of New Mexico, San Juan County, pursuant to NMSA 1978, §§ 72-4-15 through 72-4-17, under the caption and case number shown above. The purpose of this lawsuit, referred to as the "San Juan Adjudication," is to identify and determine all rights to use the surface and underground waters of the San Juan River Stream System within the State of New Mexico, which includes all tributary rivers of the San Juan River within New Mexico. The Court is proceeding on a river-by-river basis and is currently determining all rights to divert water from the La Plata River, or from a well, to irrigate land within the La Plata Section. The Court is conducting the adjudication in accordance with its April 30, 2006 Scheduling Order Governing Adjudication of Irrigation Water Rights in the La Plata Section ("Scheduling Order"), which imposes deadlines, detailed adjudication procedures, and filing requirements. A copy of the Scheduling Order and other pertinent information may be obtained from the Court's website at <http://www.11thjdc.com/modules/tinycontent/?id=79> or by contacting the State's attorney identified below. If you have not already been served in this adjudication, you are required to appear before the Court and describe what rights, if any, you claim to use the waters of the La Plata River. Unless you file a responsive pleading or Notice of Claim ("NOC"), which you may obtain from the Court's website, with the Court within sixty (60) days after the last date this Notice is published, any right you may have to use the waters of the La Plata River may be adjudicated by default judgment to the original or revised findings

of the State Engineer's 1938 Hydrographic Survey Report. The default judgment may include a determination that the claimant has no lands with appurtenant irrigation water rights within the La Plata Section and/or no right to divert surface water or underground water for irrigation within the La Plata Section.
