REGARDING UNRESOLVED WATER RIGHT**

The purpose of the scheduling conference is to assess the status of disputed Subfile SJLP-004-0035B, Court Case number AF-01-521, associated with claimant(s) LEOTA M. TRUBY, and to determine if this case should be referred to mediation.

**Attendance at the Scheduling Conference is mandatory.** The Court may enter sanctions against any party who fails to attend the Scheduling Conference, including entry of a Default Order adjudicating the water right as described in the Consent Order proposed by the State of New Mexico, *ex rel.* State Engineer. If the State and subfile claimant(s) resolve all issues relating to claimant's water right prior to the Scheduling Conference, the claimant need not attend the Scheduling Conference.
