

**NOTICE OF MANDATORY SCHEDULING CONFERENCE**  
**REGARDING UNRESOLVED WATER RIGHT**

PLEASE TAKE NOTICE that the Court has set a scheduling conference to be held at 1:00 PM on Thursday, April 30, 2015, at the Eleventh Judicial District Courthouse at 103 South Oliver Drive, Aztec, New Mexico, **with a video link to the Court of Appeals, 237 Don Gaspar, Santa Fe, New Mexico.** The purpose of the scheduling conference is to assess the status of disputed Subfile SJLP-006-0001, Court Case number AF-01-591, associated with claimant(s) AUBREY DUNN, COMMISSIONER OF PUBLIC LANDS, and to determine if this case should be referred to mediation and/or set for trial.

**Attendance at the Scheduling Conference is mandatory.** The Court may enter sanctions against any party who fails to attend the Scheduling Conference, including entry of a Default Order adjudicating the water right as described in the Consent Order proposed by the State of New Mexico, *ex rel.* State Engineer. If the State and subfile claimant(s) resolve all issues relating to claimants' water right prior to the Scheduling Conference and the State so informs the Court, the claimant need not attend the Scheduling Conference.
