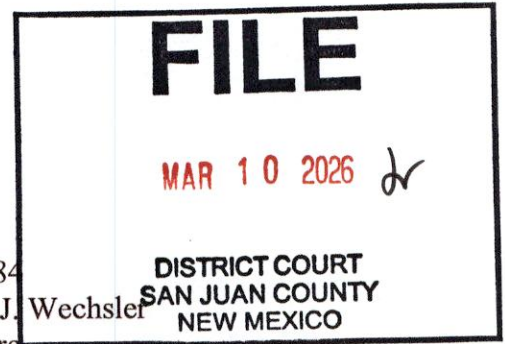

**NOTICE OF COMPLETION OF BRIEFING**

In accordance with Rule 1-007.1(H), Plaintiff, State of New Mexico *ex rel.* State Engineer (“State”), hereby gives notice that briefing is complete on the State’s *Global Motion to Correct Mistakes Regarding Map Errors in Twenty-One Consent Orders in the La Plata Adjudication*, filed on October 30, 2025 (“Maps Motion”).

No responses to the Maps Motion were filed within the thirty days allowed for returning the *Claimant’s Objection to Global Motion to Correct Mistakes Regarding Map Errors in Twenty-One Consent Orders in the La Plata Adjudication*.

However, on further review, counsel for the State discovered that one of the “Error” fields was incorrect in the Appendix filed with the Maps Motion. Upon review of the map for

Court No. AF-01-186/Subfile No. SJLP-005-0005, the “Error” field incorrectly stated: “Polygon B on map is showing 0.1 acres of No Right.” That “Error” field should state: “Polygon B on map is showing 1.0 acre of No Right.” This will be corrected in the Appendix to be filed with the Proposed Order. Minor typos will also be addressed in the Appendix for the Proposed Order.

The Maps Motion is ready for the Court’s decision. A modified Proposed Order will be filed with the Court shortly after the Court’s receipt of this Notice.
