**ORDER CORRECTING INCORRECT OR MISSING PRIORITY DATE AND RATE OF
FLOW IN SIXTY-SIX CONSENT ORDERS IN LA PLATA ADJUDICATION**

THIS MATTER having been reviewed by the Court on the *Global Motion to Correct Incorrect or Missing Priority Date and Rate of Flow in Sixty-Six Consent Orders in La Plata Adjudication* ("Global Motion"), filed by the State of New Mexico ex rel. State Engineer ("State") and having been heard by the Court, and the Court, being fully advised in the premises,
FINDS:

1. The State makes its Global Motion under the authority of the Court's Order on the State's Rule 1-060(B) Procedure Motion, entered February 28, 2023.¹ ("Procedural Order")
2. Because the majority of the above-captioned subfiles have an incorrect or missing Priority Date, and also have an incorrect or missing Rate of Flow, in the interest of promoting judicial efficiency, the State combined two categories from the Procedural Order (paragraph 4, parts g and h) into one Global Motion.
3. This Court entered Consent Orders adjudicating the water rights in the La Plata Section of the San Juan River Basin for each of the above-captioned subfile orders. The relevant information regarding the Consent Orders for each of the above-captioned cases is included in the Appendix to this Order.
4. For each of the above-captioned subfiles, the Appendix describes each incorrect or missing Priority Date and provides a correct Priority Date. The Appendix also describes each incorrect or missing Rate of Flow and provides a correct Rate of Flow.
5. All the above-captioned cases should be corrected by an Order of the Court to reflect the State's proposed changes to the Priority Date and Rate of Flow as described in the Appendix, to conform with the adjudicated water rights.
6. Correcting the Consent Orders will advance the La Plata Adjudication proceedings and will ensure that the Consent Orders accurately reflect the distribution of water within the La Plata.
7. Even though the Consent Orders listed in the Appendix were adjudicated as many as eighteen years ago (from 2008 to 2017), the State's Global Motion was made within a reasonable time. It addressed matters that came to light toward the end of an adjudication

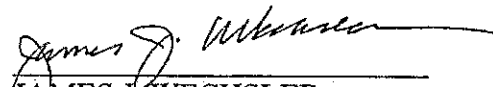
process which, of necessity, takes several years. The Global Motion addressed matters, some of which were brought to the State's attention by the Court's Database Manager, which affect substantive aspects of the Defendants' water rights.

8. The State provided the original Defendants who signed the Consent Orders or their current successors in interest with an opportunity to respond to this Global Motion filed on June 15, 2026. Defendants had 30 days to respond.
9. There are no outstanding objections to the Global Motion.

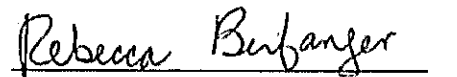
THEREFORE, IT IS ORDERED, ADJUDGED, AND DECREED that:
